This document provides instruction for creating a customized pavement asset management plan template for your specific agency by using the "DataMacro_pavementAMP_v###.xlsm" tool and accompanying folders and files (including "pavementAMP_v###.docm"), distributed to you by the Center for Technology & Training in collaboration with the Transportation Asset Management Council and the Michigan Department of Transportation.

Pavement asset data for your agency will need to be entered into the Microsoft Excel macro-enabled workbook. A portion of this data is custom exports from your Roadsoft database. To compile this data manually (if your agency does not use Roadsoft), instructions are available by contacting the CTT.

The Excel macro-enabled workbook will then parse the data for the customized Microsoft Word template. This Instruction Guide will detail how to enter data into the Excel workbook and, subsequently, generate a customized pavement asset management plan template in Word.

Saving the tools on your computer


The tools for creating a pavement asset management plan can be downloaded as a zipped file from ctt.mtu.edu/asset-management-resources. After unzipping the tools folder, it is recommended that the "pavementamp_v###_tools" folder be saved in your Documents or My Documents folder or on your desktop; if it is desired to rename this (sub)folder, use a unique name such as "PavementAMP-YYYY", where "YYYY is the current year . Please note: DO NOT RENAME the included folders or files at any time. Also, if your computer system backs up your files to an online cloud service, you will need to save the asset management plan tools to a USB drive and work with the files on the USB drive.

The tools within the "pavementamp_v###_tools" folder consist of (see figure below):

- the .xlsm file, "DataMacro pavementAMP v###.xlsm", housed in the main folder
- two subfolders
 - o the "backgroundprocesses" subfolder that contains the generic Word template "pavementAMP_v####.docm" and a subfolder "blankcsvs" with zero-populated .csv files required to make the "DataMacro_pavementAMP_v###.xlsm" tool function
 - the "csvRoadsoftExports" subfolder that serves as a repository for your Roadsoft data exported as .csv files.

Do not rename these files or folders. If Roadsoft is not your modelling/forecasting tool, please contact the CTT for assistance.

It is also recommended that any other content needed for your pavement asset management plan—such as logos and images—be kept in this folder, as well.



Exporting data from Roadsoft

NOTE: A quick guide to these exports can be found on pages 24 to 25.

These instructions for the current version of Roadsoft (2023.3 or newer) detail the process of exporting the eight required Roadsoft .csv files for the Excel pavement asset management plan workbook. All eight files are required to run the workbook steps. All export files must be saved in the "csvRoadsoftExports" folder, and the file names must have the same names as provided in the instructions.


NOTE: All eight files should be exported even if there is no corresponding data since the workbook requires all eight .csv files to run.

Preparing to export files

- 1. Create/locate the new folder you created on your hard drive for storing your pavement asset management plan files.
- 2. Launch the Roadsoft desktop application.
- 3. Select the **TAMC** menu (see figure below).
- 4. Select **Asset Management Reporting...** from the *TAMC* menu (see figure below).








NOTE: All eight exports are created in the *Road Reports* window using the following steps. If the window closes at any time during the following steps, repeat the preceding steps 3 and 4 to reopen the *Road Reports* window.

1. Export AM Plan Base (Agency Type) - SurfTwp.csv

1. Change the report name in the *Road Reports* window from the default to **Surface Type Mileage by Jurisdiction** (see figure below).




2. Change the *Mileage Type* to either **Centerline** or **Lane** from the dropdown list in the *Report Options* section of the *Road Reports* window (see figure below).



NOTE: The mileage type (i.e., centerline or lane) will only need to be selected once; this choice will remain the same for the remaining exports.


- 3. Load the AM Plan Base saved filter.
 - a. Select **Open** in the *Filter Builder* section of the *Road Reports* window (see figure below).
 - ⇒ The *Load Saved Filter* window will open.
 - b. Select **AM Plan Template** from the *Group:* dropdown list of the *Load Saved Filter* window (see figure below).
 - c. Select **AM Plan Base (City)** or **AM Plan Base (County)** from the listed filters based on your agency type (see figure below).
 - d. Select **OK** (see figure below).
 - ⇒ The saved filter will load into the *Road Reports* window.






3. Export Plan Base (Agency Type) + On NHS – Act51TwpNHS.csv

1. Change the report name in the *Road Reports* window to **Legal System Mileage By Jurisdiction** (see figure below).



- 2. Change the *Mileage Type* to either **Centerline** or **Lane** from the dropdown list in the *Report Options* section of the *Road Reports* window (refer to *1. Export AM Plan Base...SurfTwp.csv* step 2 for figure).
- 3. Load the AM Plan Base saved filter.
 - a. Select **Open** in the *Filter Builder* section of the *Road Reports* window (see figure below).
 - ⇒ The *Load Saved Filter* window will open.

- b. Select **AM Plan Template** from the *Group:* dropdown list of the *Load Saved Filter* window (see figure below).
- c. Select AM Plan Base (City) + On NHS or AM Plan Base (County) + On NHS from the listed filters based on your agency type (see figure below).

- 3. Change the *Group By* to **Legal System** from the dropdown list in the *Report Options* section of the *Road Reports* window (refer to *4. Export AM Plan Base...LatestSurfSum.csv* step 3 for figure).
- 4. Load the AM Plan Base saved filter.
 - a. Select **Open** in the *Filter Builder* section of the *Road Reports* window (see figure below).


NOTE: If the agency does not have IBR ratings for unpaved roads but does have PASER ratings for unpaved roads, choose the *Report Name* of **Latest PASER Mileage Summary** and the *AM Plan Base* saved filter of the **AM Plan Base** (**Agency Type**) + **Unpaved**. Use the *Group by* selection of **City/Twp** and save as the file name "LatestIBRSum.csv".

NOTE: Still complete the IBR export if your agency does not have unpaved roads or does not have unpaved road ratings.

1. Change the report name in the *Road Reports* window to **Latest Inventory Based Rating (IBR) Mileage Summary** (see figure below).



- 2. Change the *Mileage Type* to either **Centerline** or **Lane** from the dropdown list in the *Report Options* section of the *Road Reports* window (refer to *I. Export AM Plan Base...SurfTwp.csv* step 2 for figure).
- 3. Change the *Group By* to **City/Twp** from the dropdown list in the *Report Options* section of the *Road Reports* window (refer to 5. *Export AM Plan Base...LatestSurfSumTwp.csv* step 3 for figure).
- 4. Load the AM Plan Base saved filter.
 - a. Select **Open** in the *Filter Builder* section of the *Road Reports* window (see figure below).
 - ⇒ The *Load Saved Filter* window will open.
 - b. Select **AM Plan Template** from the *Group:* dropdown list of the *Load Saved Filter* window (see figure below).








Entering data into the Excel workbook

NOTE ABOUT DATAMACRO_PAVEMENTAMP_V###.xLsm: There are several additional worksheets built into the DataMacro_pavementAMP_v###.xlsm file. These worksheets contain all of the imported Roadsoft data as well as a sheet of background calculations. These data worksheets are hidden; the background calculations worksheet is hidden and protected. If it is necessary to access these worksheets, unhide them; be aware that modifying and unprotecting them leaves them vulnerable to inadvertent changes that will render the Excel file useless for inserting data into the Word template.

Completing the Word template

The pavement asset management plan Word template (i.e., pavementAMP_vYYYY.docm) is automatically populated with content based on your responses and charts in the pavement asset management plan workbook (i.e., DataMacro_pavementAMP_vYYYY.docm). However, several places in the Word document still require your input and editing.

1. Address all orange-text field prompts/"Your Content Here" prompts.

NOTE: <#Orange text fields> are placeholders for user-entered data. Each of these placeholders can be identified by its field formatting, its orange color, and its unique tagging "<#". Each of these placeholders has a different prompt depending on the type of information to be input. An example of an orange-text field prompt is:



To address these prompts:

- a. Navigate to the orange-text field prompts or comments/"Your Content Here" prompts.
 - i. Place your cursor on the cover page, then toggle to each prompt using the **F11** key on your keyboard.
 - OR: Visually search the document for orange-text fields and/or "Your Content Here" prompts.
 - OR: Select **Find** from the *Home* ribbon *Editing* group, and enter "<#" in the *Search document* input box. (Note: This will also find the missed auto-fills; see step 4, below).
- b. Fill in content/responses manually.

NOTE: Some orange text field prompts are associated with dropdown selections for content/responses. The chosen dropdown selection or the manually-entered content/response should flow with the context of the paragraph or section.

2. Address all teal-commented optional sections (see figure below).




NOTE: Teal-commented optional sections signal entire sections that are optional and can be deleted based on your agency's circumstances. These sections are placed in content controls. In many cases, you will have a choice between alternate teal-commented sections for the same entire section; you may delete one or all options for the entire section if it does not apply to your agency's circumstances. Optional sections are accompanied by instructions in the teal-highlighted comment. An example of an optional section's instructional comment is:

Discuss the reconstruction treatments that apply to your agency's methods used. To use/modify applicable content, right-click the content control and then select "Remove Control" to retain text; then, use/modify content.

To create new sub-sections, select the control handle and select Ctrl + C or use the Copy button in the Home ribbon Clipboard group; paste the copied content control at the bottom of the list. To delete sub-sections, select the control handle and use your Delete key to delete content. Scrolling over optional section content controls will shade the content control area in grey.


Scrolling over an optional section will show its content control and will shade the content control in grey (see figure above). At this point, you may address the teal-commented optional section in one of three ways:

- a. OPTION 1: Use and/or modify optional sections content:
 - i. Right-click anywhere inside the content control.
 - ⇒ A dropdown menu will appear.
 - ii. Select Remove Content Control (see figure below).



- ⇒ The content control is now removed and the text has merged with the body of the document. You may now edit this section as part of the body itself.
- b. OPTION 2: Create new sub-sections:
 - i. Place cursor in optional section content control.
 - ⇒ The content control frame and handle (upper left corner) will open (see figure above).

ii. Select the content control handle (see figure below).



- iii. In the *Home* ribbon, select **Copy** from the *Clipboard* group to copy the chart/graph to the Windows clipboard.
 - OR: Right-click on the chart/graph; select Copy from the dropdown menu.
 - OR: Use the **Ctrl** + **C** keyboard shortcut.
- iv. Place cursor at the end and outside the content-controlled area.
- v. In the *Home* ribbon, select **Paste** from the *Clipboard* group to paste the chart/graph that was copied to the Windows clipboard.
 - OR: Right-click on the placeholder; select **Paste** from the dropdown menu.
 - OR: Use the Ctrl + V keyboard shortcut.
- c. OPTION 3: Delete optional sections entirely:
 - i. Place cursor in optional section content control.
 - ⇒ The content control frame and handle (upper left corner) will open.
 - ii. Select the content control handle (see figure above).


- iii. Press the **Delete** key on your keyboard.
- ⇒ This removes the entire optional section.
- 3. Address missed auto-fills.
 - a. Select **Find** in the *Home* ribbon *Editing* group.

 - i. Enter "<#" in the Search document input box in the Navigation pane.
 - ii. Press Enter on your keyboard.
 - Any instances of "<#" will be found, and you will automatically advance to the first instance after your cursor's current location.
 - iii. Replace missed auto-fills with appropriate content.
 - iv. Select Next to advance to the next instance of the auto-fill placeholder.

OR

- b. Select **Replace** in the *Home* ribbon *Editing* group.
 - ⇒ The *Find and Replace* dialogue box will open.
 - i. Enter "<#" in the *Find what:* input box.
 - ii. Select Find Next.
 - Any instance of the of "C#" will be found and you will automatically advance to the first instance after your cursor's current location.
 - iii. Replace any missed auto-fills with appropriate content.
 - iv. Select **Find Next** to advance to the next instance of the auto-fill placeholder.
- 4. Address comments.

NOTE: Comments appear along the right side of the Word document. If you do not see comments, ensure that the markup dropdown menu in the *Review* ribbon *Tracking* group says "All Markup" or "Simple Markup". If you select "Simple Markup", you will need to select **Show Comments** in the *Comments* group (see figure below).

a. Delete comments when done by right-clicking on the comment and selecting **Delete**Comment from the dropdown menu (see figure below).



 - OR: Right-click where your cursor is positioned, and select **Paste** from the dropdown menu.
 - OR: Use the Ctrl+V keyboard shortcut.

Inserting images

Maps (see instruction in the section *Creating map images from Roadsoft*, below) and other images will help communicate your inventory of assets and your asset management goals.

NOTE: The procedure for creating maps in Roadsoft, exporting them as PDFs, and saving them as image files is detailed below.








Creating map images from Roadsoft

The pavement asset management plan Word template has several map images including figure 16 – inventory of pavement assets and figures 44 through 50 – pavement assets' planned projects, and figure 54 – critical links in the road and bridge network. The following procedures detail the creation of each of these maps in Roadsoft and exporting them PDF files; an additional procedure explains the process of saving a PDF file as an image. The preceding section (above)—*Inserting content into the pavement asset management plan Word Template*—details the procedure for inserting images into a Word document.

Creating image for 1. Pavement Assets > Inventory of Assets (Figure 16)

- 1. Display roads according to rating.
 - a. Select **Show Legend Window** () in the *Map tool options* bar.
 - ⇒ The *Road Legend* window will open (see figure below).
 - b. Select **Open Legend Builder** (in the *Road Legend* window (see figure below).
 - ⇒ The *Legend Builder* window will open (see figure below).




- c. Choose the **Good/Fair/Poor** field from the *Legend Field* dropdown list (see figure above).
- d. Move the good, fair, and poor rated road values down to the *Query* box of the *Legend Builder* window.
 - i. Highlight good, fair and poor unique values by selecting the first value (e.g., Good), holding down the **Alt** key on your keyboard, and selecting the subsequent unique values (e.g., Fair and Poor).

- e. Select one condition Query value in the *Items* list.
- f. Adjust color and font size of the selected value using *Feature* and *Outline* in the *Item Properties* box (see figure below).

Inserting Appendixes

To create a pavement asset management plan document with appendixes as a single file, save the pavement asset management plan Word template and any other associated files as PDFs. Then, using a PDF editing software program, merge the PDFs into a single PDF.

To save a Word document as a PDF:

1. Select **File** in the ribbon menu.



2. Select **Save as Adobe PDF** in the *File* sidebar menu (see figure below).



OR: Select **Print** in the *File* sidebar menu (see figure above).

⇒ The Windows *Print* window will open (see figure below).

- a. Select **Microsoft Print to PDF** from the *Print* window (see figure above).
- b. Select **Print** (see figure above).
- ⇒ The Save Print Output As window will open.
- c. Navigate in the *Save Print Output As* window to the desired folder containing compliance plan materials, enter a descriptive file name in the *File name* input box (e.g., *pavementAMP_YYYY* or *pavementAMP-appendix1_YYYY*, where "YYYY" is the current year), and select **Save**.

OR: In the *Home* ribbon, select **Create and Share Adobe PDF** in the *Adobe Acrobat* group (see figure below).



3. Once all necessary files have been saved as a PDF, proceed with using a PDF editor to compile all necessary PDFs into a single PDF.

Updating in Future Years

- 1. Complete the required Roadsoft exports as before and complete the steps in the Excel document.
- 2. An original template must be saved for requested form the CTT with the link data.
- 3. Once an original template is available, the transfer can be completed from Excel to the Word template.
